# Deed

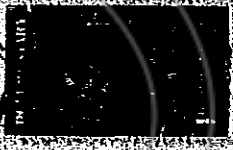
The Southwest quarter of the Northeast quarter of Section 13, Township 31 North, Range 48 East, M.D.B.M. as per Government Survey.
