

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY that the Chicago No. 3 Lode Mining Claim was located by G.M. HADRABA, whose post-office address appears below, on the 14th day of JULY, 1964.

The general course of said lode or vein is Northerly.

The claim is situated in the LYNN Mining District Eureka County, State of Nevada, and lies within Section 4.  
Township 35 North Range 50 East Mt. Diablo, Meridian

The locator's claim 1400 feet in a Northerly direction and 100 feet in a SOUTHERLY direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: Drill and/or drill holes on the nine contiguous Chicago claims applicable to the entire group plus excavations near discovery monuments, each item exceeding lawfully required work limits.

The total cost of such work, <sup>applicable to this claim</sup> consisted of at least \$ 100.00.

The corners and side centers of the claim are located and marked as follows: From the southwest corner, a monument marked Southwest SW Cor. thence in a northerly direction 750 feet to the West side center <sup>WSC</sup> ~~northwest corner~~, a monument marked West side center <sup>WSC</sup> ~~SW~~ Cor., thence 750 feet in an Northerly direction to the north west corner <sup>NWC</sup> ~~corner~~, a monument marked Northwest <sup>NWC</sup> ~~ESC~~, thence 600 feet in an easterly direction to the northeast corner, a monument marked Northeast NE Cor., thence 750 feet in a southerly direction to the East side center <sup>ESC</sup> ~~corner~~, a monument marked East side center <sup>ESC</sup> ~~SE~~ Cor., thence 750 feet in a Southerly direction to the south east corner <sup>SEC</sup> ~~corner~~, a monument marked South east <sup>SEC</sup> ~~ESC~~, thence 600 feet westerly to the point of beginning.

Each of the above-described monuments is 4 x 4 posts.

All location and discovery work necessary to complete this location had been performed by October 12th, 1964.
