CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the PAT 76 Lode Mining Claim was located by Robert L. Redmond on August 10, 1964. The general course of said lode or vein is east/west. The claim is situate in the Cortex (unorganized) Mining District, Eureka County, Nevada.

The locator claims 50 feet in a westerly direction and 1450 feet in a easterly direction from the location moment, and a width of 300 feet on each side of the center of the wein or lode along the entire length of said claim.
