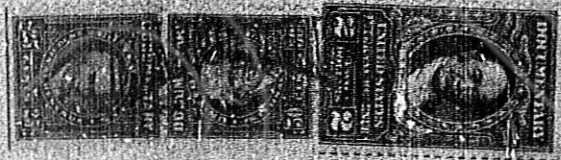
WITNESSETH:
