 has been paid so far as the hereinafter described property is affected thereby:

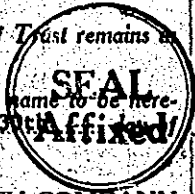
NOW, THEREFORE, **NEVADA TITLE GUARANTY COMPANY**, a Nevada
