WITNESSETH:

That for and in consideration of the sum of Ten Dollars (\$10.00), lawful money of the United States of America, to them in hand paid by Grantee, receipt whereof is hereby acknowledged, Grantor does hereby and by these presents grant, bargain sell and convey unto Grantee, the following described piece, parcels and plots of land bounded and described as follows, to-wit:
