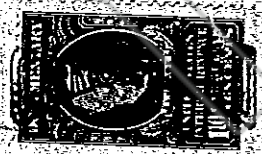
WITNESSETH:

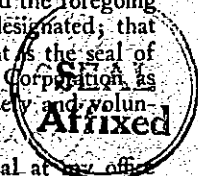
