Court that she is a resident of the County of Elko, State of Nev-  
ada, and the Wife of JOE ANDREOZZI, deceased.

That said Deceased died in the City of Elko, County of  
Elko, State of Nevada, on December 19, 1963, and was, at the time  
of his death, a resident of the County of Eureka, State of Nevada,  
and left an Estate consisting solely of:

A certain 1951 Mercury Six-Passenger  
Coupe, Motor No. 51LA-17606M, having  
an approximate value of \$75.00, and  
two frame houses, one shed and one  
barn, together with certain household  
furniture all situate in Beowawe, Eureka  
County, Nevada, having a value of \$750.00.

That due search and inquiry were made to ascertain if
