**WITNESSETH:**

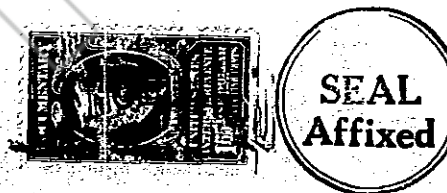
