Witnesseth: That the said party of the first part, in consideration of the sum of TEN (\$10.00) dollars, lawful money of the United States of America, to him in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do hereby these presents grant, bargain, and sell unto the said parties of the second part, and to their heirs and assigns forever, all

that certain lot, piece or parcel of land situate in Eureka County of Nevada, and bounded and described as follows, to-wit:

Beginning at Corner No. 1 from which the east one-quarter corner of Section 13, T. 27 N., R. 51 E., M. D. B. & M., bears S. 18° 47' E., 1288.00 feet, thence N. 55° 10' W., 628.2 feet to Corner No. 2, a point in the southeast boundary line of Highway No. 20, thence N. 34° 50' E., 832.00 feet along said southeast boundary line to Corner No. 3, thence S. 55° 10' E., 504.27 feet to Corner No. 4, thence S. 1° 13' E., 210.90 feet to Corner No. 5, thence S. 34° 50' W., 661.40 feet to Corner No. 1, the point of beginning.
