Witnesseth: that the party of the first part, in consideration of the sum of TEN (\$10.00) dollars, lawful money of the United States of America, to him in hand paid by the part y of the second part, the receipt whereof is hereby acknowledged, does hereby release and forever **QUITCLAIM** unto the party of the second part, and to its heirs and assigns, all that certain lot, piece, or parcel of land situate in the County of Eureka

State of Nevada, and bounded and described as follows, to-wit:

A right-of-way 25.00 feet in width lying 12.50 feet on either side of a centerline located across Lot 1 (NE $\frac{1}{4}$, NE $\frac{1}{4}$) of Section 14, T 19 N, R 53 E, M. D. B. & M., more particularly described as follows:

Commencing at station 6+24 on an 8" sewer outfall line which is a point located on the northerly line of the Old-Put mill site, said point bearing N 37° 00' W 415.00 feet from the N 1/16 corner between Sections 13 and 14 of said T 19 N, R 53 E, thence, N 16° 26' W 190.00 feet to station 8+14 of said sewer outfall line which is a point on the south-westerly line of the old treatment plant site located S 20° 36' W 862.00 feet from the northeast section corner of said Section 14:

Thence, from station 9+17 of said outfall line a point located in the northerly line of the old treatment plant site, from which the said northeast section corner of Section 14 bears N 23° 02' E 778.00 feet, N 0° 02' E a distance of 716.09 feet to station 16+33.09 a point on the northerly line of said Section 14, 306.30 feet west of the northeast section corner of said Section 14.
