SULLIVAN RIG (trailer mounted)

- 1 Model 300 Sullivan trailer mounted drill rig, It has a 58 foot derrick and is powered by 2 Continental model B427-385 engines, SAE rating of each engine is 44.6 HP. The sand reel was manufactured by General Machine Works and is powered by a Waukesha engine, industrial unit model #FCUIU-644V
- 1 Sullivan 3 sheave traveling block
- 1 Model OB-12 Brewster oil bath rotary table with 12½" API opening
- 1 Ideal square rotary kelly drive bushing.
- 1 Martin Decker weight indicator
- 1 6" Mission slip
- 1 Set (2) 3½" Mission slips
- 1 Set (2) Webb Wilson type C rotary tongs
