13 the amount of Two Thousand Five Hundred Fifty-one and 68/100 Dollars
14 (\$2551.68), lawful money of the United States, together with the sum of
15 Fifteen Dollars Court costs and Five Hundred Dollars attorney fees and
16 hereby consents that the Clerk of the above-entitled Court duly enter judg-
17 ment for the total amount of Three Thousand Sixty-six and 68/100 Dollars
18 (\$3,066.68) against me.

20 myself to said claimant as payment in full for groceries and merchandise.

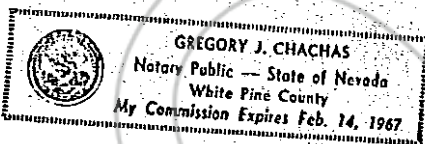
