TO HAVE AND TO HOLD the said premises, together with the appurtenances unto the said Parties of the Second Part and to their heirs and assigns forever.



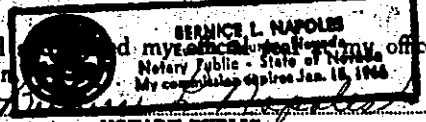
