

MINING DEED

THIS INDENTURE, made the 18th day of August, 1965, by and between EDWARD MEYER of the State of New York, Party of the First Part, and CARLIN GOLD MINING COMPANY, a Delaware corporation, Party of the Second Part,

W I T N E S S E T H:
