

KNOW ALL MEN BY THESE PRESENTS, that M. H. WHITE, being first duly sworn, deposes and says:

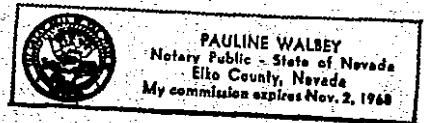
That at the instance of the affiant, CARLIN GOLD MINING COMPANY, that it expended more than \$100.00 per claim for labor or improvements, as the annual assessment work for the year ending September 1, 1965, on all of the aforesaid claims, in the Lynn Mining District, Eureka County, Nevada, owned by CARLIN GOLD MINING COMPANY, for the purpose of holding all of the aforesaid claims.

Said labor was performed by employees and contractors, Worthington Construction Company and its employees, Eklund Drilling Company and its employees, and Willis Brothers Construction Company and its employees, between the sixth (6th) day of July 1965, and the first (1st) day of September, 1965, and that more than 54 days of labor were performed. Such work or improvements, and character, consisted of drilling a rotary drill hole 470 feet deep on the Par No. 6 claim; drill road construction; and 12 test pits having a width of 2 feet, an average length of 8.9 feet and an average depth of 4.3 feet on the Par Claim Nos. 4 and 5.
