lease and forever QUITCLAIM unto the party of the second part, and to its

heirs and assigns, ^{only} those certain lots, pieces, or parcels of land situate in the

State of Nevada, and bounded and described as follows, to-wit:

The following parcels inter alia are subject to a certain Mining Lease dated August 1, 1964, made and executed between the party of the first part as Lessee and the party of the second part as Lessor, of which a Memorandum of Lease was recorded on October 5, 1964, in Book 6 of Official Records, pages 61-63, Records of Eureka County, Nevada, and also was recorded on October 28, 1964, in Book 6 of Official Records, pages 141-143, Lander County, Nevada.
