

JOINT TENANCY DEED

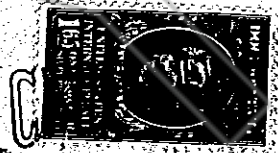

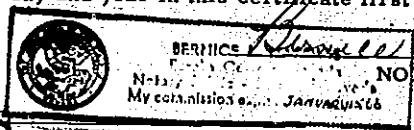
