There was expended for said labor and improvements and they are of a value in excess of One Thousand Four Hundred Dollars (\$1,400.00); and they were performed and made by Sprague and Henwood Inc., under a contract with Ussram Exploration Company and at the expense of said Ussram Exploration Company.

The said labor was performed and improvements made between 12:00 o'clock Meridian, September 1, 1965 and September 9, 1965, and consisted of: first, continuing drill hole S-10-2, situated on said Sunshain No. 10 claim; second, in drilling holes S-1-1 and S-1-2, situated on said Sunshain No. 1 claim, from surface; third, in drilling holes S-3-1 and S-3-2, situated on said Sunshain No. 3 claim, from surface; fourth, in drilling hole No. S-4-1, situated on said Sunshain No. 4 claim, from surface; fifth, in drilling hole No. S-10-3, situated on said Sunshain No. 10 claim, from surface; and, sixth, in drilling holes Nos. S-11-3 and S-11-4, situated on said Sunshain No. 11 claim, from surface; the total advance in said holes was 352 feet.

The above named and described unpatented mining claims comprise a contiguous group of lode mining claims owned in common by Ussram Exploration Company. The said labor was performed and improvements made for the benefit of each and all of said mining claims comprising said contiguous group as a part of a general plan of development, and they tend to improve and develop each and all of said mining claims.
