

JOINT TENANCY DEED

WITNESSETH:

The Northwest quarter of the Northwest quarter; the South half of the Northwest quarter; and the Northwest quarter of the Southwest quarter, all of Section 9, Township 31 North, Range 48 East, M.D.B.M., as per Government Survey.

RESERVING THEREFROM an easement of 30 feet along all boundaries for ingress and egress, with power to dedicate.

- SUBJECT TO: (I. Taxes due not heretofore paid.
- II. Covenants, conditions, restrictions, reservations, easements, rights and/or rights of way of record.

Together with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said parties of the second part, and to the survivor of them, and to the heirs and signs of such survivor forever.
