THIS INDENTURE, made this 8th day of November, 1965 by and between TERESA SANSINENA, formally known as THERESA MAHONEY, party of the first part, and PAUL SANSINENA, her husband, party of the second part, both of the County of Eureka, State of Nevada.

W I T N E S S E T H :

WHEREAS, the party of the first part executed and delivered a Deed to the party of the second part which Deed contained an erroneous description of the property meant to be conveyed and the correct description of said property should be as hereinafter set forth in this Deed; that said Deed was recorded April 21, 1965 in Book 7, page 210 file No. 40776 of the Official Records, Eureka County, Nevada

WHEREAS, it is the desire of the parties to execute this Deed of Correction for the purpose of correcting the description of said property.

NOW THEREFORE, the said party of the first part, for and in consideration of the sum of TEN AND NO/100 DOLLARS (\$10.00), lawful money of the United States of America, to her in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain and sell unto the party of the second part, to his heirs, executors, administrators and assigns, forever, that property situate in the County of Eureka, State of Nevada particularly described as follows, to-wit:
