Those certain portions of the S 1/2 of the SW 1/4 and the SW 1/4 of the SE 1/4 of Section 12, T. 32 N., R. 50 E., M.D.B. & M., lying and being left and northerly of the left or northerly highway right of way line of Interstate Route 80, State Rcute 1 (IR-80, SR-1).

Grantee, its contractors, agents and employees, shall have the right of ingress to and egress from said right of way and the electric power line thereon for the exercise of the rights herein grantes, with the specific understanding the Grantee shall be responsible for any damage to personal property or improvements, suffered by Grantor. by reason of the construction, maintenance, or repair of said line.

Grantee shall have the right from time to time to increase or decrease the size and number of poles, wires, and appurtenances, which may be installed in or upon the right of way hereby granted, and to cut and remove brush and timber which may interfere with the operation of said power line.
