
#### WARRANTY DEED

TOGETHER WITH all improvements of every nature, kind and description situate thereon.

TOGETHER WITH all waters, water rights, rights to the use of water, dams, ditches, canals, pipe lines, reservoirs and all other means for the diversion or use of waters appurtenant to the said property or any part thereof, or used or enjoyed in connection therewith, and together with all stockwatering rights used or enjoyed in connection with the use of any of said lands; and together with all range rights, grazing rights and in particular, but without limitation thereto, all rights to graze livestock on the public domain under what is known as the Taylor Grazing Act, owned by First Party or used or enjoyed in connection with any of said property.

TOGETHER WITH the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

RESERVING unto the First Party an undivided one-half interest in and to all of the right, title and interest of First Party in and to all oil, gas and mineral rights, tegether with sufficient right of way of ingress and egress in case any gas, oil and other minerals are found on said premises in commercial quantities for enjoyment thereof.

SUBJECT TO any and all easements, rights of way or licenses, for United States, State and County highways and roads, and telephone, telegraph, power lines, pipe lines and fences, either created and evidenced by recorded written conveyance or agreement, or by actual occupancy which may be ascertained by examination and observations of said real property as of the date hereof; and further subject to any reservations and exceptions in and to minerals by the United States or State of Nevada, and any and all predecessors in interest to First Party; and further subject to so-called Thermal Leases from First Party to JOSEPH I. O'NEILL, JR., of Midland, Texas, to land situate in T. 28 N., R. 49 E.; T. 29 N., R. 48 E.; and T. 29 N., R. 29 E.

TO HAVE AND TO HOLD all and singular the above-described premises, together with the appurtenances, unto the said Second Party, and to its successors and assigns forever; and First Party and his heirs, the premises in the quiet and peaceful possession of Second Party, its successors and assigns, against the First Party and his heirs, and against all and every person and persons whomsoever, lawfully claiming or to claim the same, shall and will warrant, and by these presents forever defend (except for the exceptions and reservations hereinabove set forth generally or specifically in the body of this Deed).


