

LOCATION CERTIFICATE

This is to certify that the HILL TOP FRACTION NO. 2 lode mining claim was located by (Beulah K. Murphy and Dorothy K. Fronberg) on the 2nd day of December, 1965, at 2:00 P.M.

The general course of said vein or lode, as near as it may be described is

N. 52 $\frac{1}{4}$ ° E. and S. 52 $\frac{1}{4}$ ° W.

The claim is situated in the Lynn mining district, Eureka County, State of Nevada, and the discovery monument is located approximately N. 84° E. 1075 feet distant from the west $\frac{1}{4}$ corner of Section 12, T. 35 N.; R. 50 E.; M. D. B. & M.

The locator claims 300 feet in a N. 52 $\frac{1}{4}$ ° E. direction and 1200 feet in a S. 52 $\frac{1}{4}$ ° W. direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claims are as follows: a rotary drill hole, 120 feet deep, on the Hill Top Fraction No. 4, costing more than \$300.00.

Such work was done at one point(s) within a group of contiguous claims and results in tending to advance the exploration of such claims as a group. The names of which said group of claims are as follows: Hill Top Fraction No. 2, Hill Top Fraction No. 3 and Hill Top Fraction No. 4.

The corners and side centers of this claim are located and marked as follows:

Beginning at the northwest corner, a 4"x4"x4 $\frac{1}{2}$ " wood post marked N.W. corner H. T. Frac. No. 2 thence S. 52 $\frac{1}{4}$ ° W. 750 feet, West 1500 side center, a 4"x4"x4 $\frac{1}{2}$ " wood post marked W. side center, H. T. Frac. No. 2, feet to the SW. corner, a 4"x4"x4 $\frac{1}{2}$ " wood post marked SW. corner H. T. Frac. No. 2; thence East 760 feet to the Southeast corner, a 4"x4"x4 $\frac{1}{2}$ " wood post marked SE. corner H. T. Frac. No. 2; thence N. 52 $\frac{1}{4}$ ° E. 750 feet, east 1500 side center, a 4"x4"x4 $\frac{1}{2}$ " wood post marked E. side center, H. T. Frac. No. 2, feet to the NE. corner, a 4"x4"x4 $\frac{1}{2}$ " wood post marked NE. corner H. T. Frac. No. 2; thence West 760 feet to the northwest corner, the place of beginning overlaps the Hill Top Fraction Nos. 1, No. 3 & No. 4.

The West side line of this claim is contiguous with the side line of the claim; overlaps the Hill Top Fraction No. 4 & Unity No. 2; the south end line is contiguous with the end line of the claim; overlaps the Unity No. 2, Compromise No. 7 and Hill Top No. 2; the east side line is contiguous with the side line of the claim; overlaps Hill Top No. 2 and Hill Top Frac. No. 1; the north end line is contiguous with the end line of the claim;
