

LOCATION CERTIFICATE

This is to certify that the HILL TOP FRACTION NO. 4 lode mining claim was located by (Baulah K. Murphy and Dorothy K. Fronberg) on the 2nd day of December, 1965, at 3:00 P.M.

The general course of said vein or lode, as near as it may be described is N 11° E and S 11° W.

The claim is situated in the Lynn mining district, Eureka County, State of Nevada, and the discovery monument is located approximately S 7° E 755 feet distant from the West 1/4 corner of Section 12, T. 35 N., R. 50 E., M. D. B. & M.

The locator claims 100 feet in a N 11° E direction and 1400 feet in a S 11° W direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claims are as follows: a rotary drill hole, 120 feet deep, on the Hill Top Fraction No. 4, costing more than \$300.00.

Such work was done at one point(s) within a group of contiguous claims and results in tending to advance the exploration of such claims as a group. The names of which said group of claims are as follows: Hill Top Fraction No. 2, Hill Top Fraction No. 3 and Hill Top Fraction No. 4.

The corners and side centers of this claim are located and marked as follows:

Beginning at the northwest corner, a 4"x4"x4 1/2' wood post marked N.W. corner H. T. Frac. No. 4; thence S 11° W 750 feet, West 1500 side center, a 4"x4"x4 1/2' wood post marked W side center, H. T. Frac. No. 4, feet to the SW corner, a 4"x4"x4 1/2' wood post marked SW corner H. T. Frac. No. 4; thence east 611 feet to the southeast corner, a 4"x4"x4 1/2' wood post marked SE corner H. T. Frac. No. 4; thence N 11° E 750 feet, east 1500 side center, a 4"x4"x4 1/2' wood post marked east side center, H. T. Frac. No. 4, feet to the NE corner, a 4"x4"x4 1/2' wood post marked NE corner H. T. Frac. No. 4; thence west 611 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the side line of the Rita K & Jim No. 2 claim; the south end line is contiguous with the north end line of the Alan No. 17 claim; the south end line overlaps the Paragon No. 1 claim; the east side line overlaps the Paragon No. 1 Paragon Frac., Unity No. 2 & H. T. Frac. No. 2 claims; the east side line is contiguous with the side line of the H. T. Frac. No. 2, Unity No. 2, Hill Top Frac. No. 3 & Rita K claims; the north end line overlaps the H. T. Frac. No. 2, Unity No. 2, Hill Top Frac. No. 3 & Rita K claims.

All location work necessary to complete this location had been performed by December 27, 1965.
