

## AMENDED LOCATION CERTIFICATE LODE CLAIM

This is to certify that the RITA K No. 1 lode mining claim was located by Edward Meyer on the 19th day of May, 1955 and recorded on June 22nd, 1955 in Book "J" of Outside Mining, on Page 327 (File No. 31829) in the Office of the Eureka County Recorder, Eureka, Nevada, and that subsequent thereto on August 18th, 1965 the said claim was assigned to Carlin Gold Mining Company as recorded on August 30th, 1965 in Book "8" of Official Records at page 283 in the Office of the Eureka County Recorder, Eureka, Nevada.

Notice is hereby given that the undersigned Carlin Gold Mining Company as assignee and claimant of the said RITA K No. 1 lode mining claim and preserving all rights under the said original location thereof does hereby amend the description of this claim, supplementing the information contained in the original certificate as recorded in the manner hereinafter set forth. The size, outline, and field position of the claim remains as originally recorded and this amended location is to more particularly describe the said claim as follows:

The general course of said vein or lode, as near as it may be described is N 11° 15' E and S 11° 15' W.

The claim is situated in the Lynn mining district, Eureka County, State of Nevada, in Section 11, T. 35 N.; R. 50 E.; M. D. B. & M., and the discovery monument is located N 27° 56' 51" W 2309.63 feet distant from the southeast corner of the said Section 11.

The locator claims 750 feet in a N 11° 15' E direction and 750 feet in a S 11° 15' W direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The corners and side centers of this claim are located and marked as follows:

Beginning at the northeast corner, a 4" x 4" x 4 1/2" wood post marked NE corner Rita K No. 1 which bears S 51° 48' 48" W 73.02 feet and thence N 78° 45' W 600 feet distant from the east 1/4 corner of the said Section 11, thence S 11° 15' W 750 feet, east side center, a 4" x 4" x 4 1/2" wood post marked E side center, Rita K No. 1, 1500, feet to the SE corner, a 4" x 4" x 4 1/2" wood post marked SE corner Rita K No. 1; thence N 78° 45' W 600 feet to the southwest corner, a 4" x 4" x 4 1/2" wood post marked SW corner Rita K No. 1; thence N 11° 15' E 750 feet, west side center, a 4" x 4" x 4 1/2" wood post marked W side center, Rita K No. 1, 1500, feet to the NW corner, a 4" x 4" x 4 1/2" wood post marked NW corner Rita K No. 1; thence S 78° 45' E 600 feet to the northeast corner, the place of beginning.

The east side line of this claim is contiguous with the west side line of the Rita K claim.
