

LOCATION CERTIFICATE

This is to certify that the **MORT NO. 21** lode mining claim was located by **M. H. White** on the **11th** day of **January**, 196 **6**.

The general course of said vein or lode, as near as it may be described is **east and west**.

The claim is situated in the **Maggie Creek** mining district, **Eureka** County, State of Nevada, and the discovery monument is located approximately **north 1100 1/2 feet and west 100 feet from the SE corner Section 34, T. 34 N., R. 51 E., M. D., R. & M.**

The locator claims **100** feet in a **east** direction and **1400** feet in a **west** direction from the point of discovery, **with 160 feet south and 200 feet north** on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claims are as follows: a rotary drill hole, 265 feet deep as of January 26th, on the Mort No. 21 claim, and costing more than \$500.00.

Such work was done at **one** point within a group of contiguous claims and results in tending to advance the exploration of such claims as a group. The names of which said group of claims are as follows: **Mort Nos. 18, 19, 20, 21 and 22.**

The corners and side centers of this claim are located and marked as follows:

Beginning at the northwest corner, a 4"x4"x4 1/2' wood post marked N.W. corner **Mort No. 21**; thence **east 750 feet, north** side center, a 4"x4"x4 1/2' wood post marked **N. side center, Mort No. 21, 1500** feet to the **NE** corner, a 4"x4"x4 1/2' wood post marked **NE corner Mort No. 21**; thence **south 360 feet to the southeast** corner, a 4"x4"x4 1/2' wood post marked **SE corner Mort No. 21**; thence **west 750 feet, south** side center, a 4"x4"x4 1/2' wood post marked **S. side center, Mort No. 21, 1500** feet to the **SW** corner, a 4"x4"x4 1/2' wood post marked **SW corner Mort No. 21**; thence **north 360 feet to the northwest corner, the place of beginning.**

The **partial north** side line of this claim **overlaps** the **partial south** side line of the **Mort No. 20** claim and overlaps the Elements claims; the **east** end line is contiguous with the **partial west** line of **Section 35**; the **south** side line is contiguous with the **north** side line of the **Mort No. 10** claim; the **partial west** end line is contiguous with the **east** end line of the **Mort No. 22** claim and overlaps the Elements claims.

All location work necessary to complete this location had been performed by **January 26, 1966.**
