10 SETTLEMENT OF FIRST AND FINAL ACCOUNT
11 AND DECREE OF DISTRIBUTION

12 STANLEY R. POPE, as Administrator, having on the 19th day of
13 November, 1965, filed in this Court his First and Final Account and Petition
14 for Distribution, said matter coming on regularly to be heard on the 6th day
15 of December, 1965, notice of hearing of said Petitions having been given in
16 the manner provided by law, and at said time and place said Administrator
17 appearing in person and being represented in Court by his Attorney, GREGORY
18 J. CHACHAS, ESQ., and the Court hearing evidence adduced on behalf of
19 said Account and Petition for Distribution, and it appearing to the satisfac-
20 tion of the Court that due and legal notice of the hearing of First and Final
21 Account and Petition for Distribution was given in the manner and form as
22 required by law, and that the residue of said estate, consisting of the pro-
23 perty hereinafter described, is now ready for distribution, and said estate
24 is now ready to be closed;

26 That the said HARRY R. CLARK, died intestate on or about the 5th
27 day of January, 1962; in the County of San Mateo, State of California, being
28 at the time of his death a resident of the State of California, and that said
29 Decedent left estate in the County of Eureka, consisting of a certain patented

1 mining claim known as the "NEWBURG" in the Cortez Mining District.

2 That the said STANLEY R. POPE was appointed and qualified as
3 Administrator the 17th day of November, 1964.

4 That due Notice To Creditors was given as required by law and that
5 all liens have been paid.

6 That STANLEY R. POPE the surviving grandson of the above-named
7 Decedent, is the sole and only person entitled to the assets of said estate.

8 That the said Stanley R. Pope as Administrator has received no com-
9 pensation whatsoever for or on account of his services rendered and to be
10 rendered and should be allowed a reasonable fee therefor.

11 That GREGORY J. CHACHAS, ESQ., has rendered legal services to
12 Petitioner herein and to the date hereof has received no compensation for his
13 services rendered.

14 That E. C. LEUTZINGER, WILLIS A. DePAOLI and WALTER
15 PARONI, the Court appointed Appraisers herein have rendered services to
16 the estate herein and to date hereof have received no compensation for such
17 services; and good cause appearing therefor,

18 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the First
19 and Final Account and Petition for Distribution is approved, allowed and
20 settled.

21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
22 Stanley R. Pope as Administrator be paid One Hundred Fifty
23 Dollars (\$ 150), for his services rendered as Administrator.

24 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
25 Gregory J. Chachas, Esq., be paid the sum of One Hundred Fifty
26 Dollars (\$ 150), for his services rendered herein.

1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that E. C.
 2 LEUTZINGER, WILLIS A. DePAOLI and WALTER PARONI be paid the sum
 3 of Ten Dollars (\$ 10.00) each as and for their services
 4 rendered as Appraisers.

5 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
 6 residue of the said estate hereinafter described and any other property not
 7 now known or discovered which may belong to the estate, or, which said
 8 estate may have an interest, be and the same is hereby distributed to
 9 STANLEY R. POPE as his sole and separate property.

11 The following is a particular description of said residue of said estate:

12 Patented Mining Claim known as the "NEWBURG"
 13 located in Section 32, T. 27 N., R. 48 E., M. D. B. & M.,
 14 Cortez Mining District, Eureka County, Nevada.

15 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
 16 said Stanley R. Pope be discharged of his duties and trusts as Administrator.
