The North half of Lot 2 of the Northwest Quarter and the Southwest Quarter of Lot 2 of the Northwest Quarter of Section 7, Township 29 North, Range 49 East, M.D.B. & M., as per Government Survey.

RESERVING THEREFROM an easement of 30 feet along all boundaries for ingress and egress, with power to dedicate.

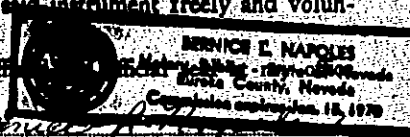
