10 DECREE SETTling FIRST AND FINAL ACCOUNT
11 OF ADMINISTRATOR AND FINAL DISTRIBUTION

12 DANIEL J. HURLEY, SR., as Administrator having on the 2nd day
13 of February, A. D. 1966, filed in this Court his First and Final Account
14 and Petition for Distribution, said matter coming on regularly to be heard
15 on the 14th day of February, 1966, notice of hearing of said Petitions having
16 been given in the manner provided by law, and at said time and place said
17 Administrator represented in Court by his Attorney, GREGORY J. CHACHAS,
18 ESQ., and the Court hearing evidence adduced on behalf of said account and
19 Petition for Distribution, and it appearing to the satisfaction of the Court
20 that due and legal notice of the hearing of First and Final Account and Peti-
21 tion for Distribution was given in the manner and form as required by law,
22 and that the residue of said estate, consisting of real property hereinafter
23 described is now ready for distribution and said estate is now ready to be
24 closed;

26 That the said, PAULINE HURLEY, deceased, died intestate on or
27 about the 16th day of August, 1945; in the County of Eureka, State of Nevada,
28 being at the time of her death a resident of the State of Nevada, and that said
29 Decedent left estate in the County of Eureka, consisting of certain real

1 property, described as follows, to-wit:

2 REAL PROPERTY: (Taken from Inventory)

3 Lot Six (6) in Block Thirty-six (36), situate in the Town
 4 of Eureka, State of Nevada, consisting of a store building
 5 together with any improvements thereon situate, having
 an estimated value of \$ 4,000.00

6 and

7 Lots Nine (9) and Ten (10), in Block Five (5), situate in
 8 the Town of Eureka, State of Nevada, consisting of a
 brick house, having an estimated value of \$ 1,000.00
 9 Total estimated value..... \$ 5,000.00

10 That the said DANIEL J. HURLEY, was appointed and qualified as
 11 Administrator the 29th day of December, 1955.

12 That due Notice To Creditors was given as required by law and that
 13 all liens have been paid.

14 That DANIEL J. HURLEY, SR., the surviving husband of the above-
 15 named Decedent, is the sole and only person entitled to the assets of said
 16 estate.

17 That the said Daniel J. Hurley as Administrator has received no
 18 compensation whatsoever for or on account of his services rendered and to
 19 be rendered and should be allowed a reasonable fee therefor.

20 That GREGORY J. CHACHAS, ESQ., has rendered legal services to
 21 Petitioner herein and to the date hereof has received no compensation for
 22 his services rendered.

23 That WILLIS A. DePAOLI, CARLTON S. THOMAS and TOM PASTOR-
 24 INO, the Court appointed Appraisers have been paid for their services ren-
 25 dered as provided by law.

26 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the First
 27 and Final Account and Petition for Distribution is approved, allowed and
 28 settled.

1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Daniel
2 J. Hurley, as Administrator be paid Two Hundred Twenty and no/100 Dollars
3 (\$220.00), for his services rendered as Administrator.

4 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Gregory
5 J. Chachas, Esq., be paid the sum of Two Hundred Fifty and no/100 Dollars
6 (\$250.00), for his services rendered herein.

8 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
9 residue of the said estate hereinafter described and any other property not
10 now known or discovered which may belong to the estate, or, which said
11 estate may have an interest, be and the same is hereby distributed to DANIEL
12 J. HURLEY, SR., as his sole and separate property.

13 The following is a particular description of said residue of said estate:

14 REAL PROPERTY:

15 Lot Six (6) in Block Thirty-six (36), situate in the Town
16 of Eureka, State of Nevada, consisting of a store building,
17 together with any improvements thereon situate, having
18 an estimated value of\$ 4,000.00

20 Lots Nine (9) and Ten (10), in Block Five (5), situate in
21 the Town of Eureka, State of Nevada, consisting of a
22 brick house, having an estimated value of\$ 1,000.00
23 Total estimated value \$ 5,000.00

24 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
25 said Daniel J. Hurley, be discharged of his duties and trusts as Administrator.
