And the Party of the First Part, for himself, his heirs and assigns, covenants and agrees to and with the Party of the Second Part, his heirs and assigns, the above bargained premises in the quiet and peaceable possession of the said Party of the Second Part. his heirs and assigns, against all and every person or persons lawfully claiming or to claim the whole or any part thereof, by, through or under the said Party of the First Part, to WARRANT AND FOREVER DEFEND.
