

Deed

THIS INDENTURE, made and entered into this 29th day of March, 1966, by and between CRESCENT VALLEY RANCH & FARMS, a Nevada corporation, party of the first part, and ERNEST CARLYLE LYNCH III and VERNA FAYE LYNCH, husband and wife as Joint Tenants, parties of the second part,

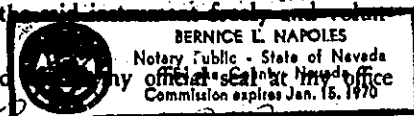
