

## \*\*\*\*\* AMENDED NOTICE \*\*\*\*\*

NOTICE IS HEREBY GIVEN, That Mr. Kenneth A. Sherman and Mr. Tom P. Costas, of Salt Lake City, Utah whose offices are located at 39 Exchange Place, Suite 26-27, have duly recorded Certificates of Location on the Thrust No.1 to 7 and have filed same in the County Recorders Office as follows:
