

BILL OF SALE

THIS BILL OF SALE, made as of the 3rd day of June, 1966, by and between PIETRINA ETCHEGARAY, a widow, and LeROY W. ETCHEGARAY, also known as LeROY ETCHEGARAY and LeROY WAYNE ETCHEGARAY, and MARY JEANNE ETCHEGARAY, his wife, of the County of Eureka, State of Nevada, First Parties, and SANTA FE LAND & CATTLE CORPORATION, a Nevada corporation, Second Party,

W I T N E S S E T H:

That the said First Parties, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to them in hand paid by the said Second Party, and other good and valuable consideration, receipt whereof is hereby acknowledged, do by these presents sell, assign, transfer, set over and deliver unto the said Second Party, its successors and assigns forever, the following described personal property, to-wit:

LIVESTOCK:

263 head of mother cows, plus all calves
40 mixed short yearlings
12 bulls

All of said cattle being branded with the VL Brand and with the following earmark ().

TOGETHER with any and all other cattle owned by the First Parties, whether the same are described hereinabove or not, branded with the VL Brand and owned by the First Parties.

18 head of horses, including 2 work mares and 2 work colts, 4 broke saddle horses, consisting of a pinto, a sorrel, a bay and a sorrel-roan, with the balance, to-wit, 10 head, being ten head of mixed range horses, all branded with the VL Brand.

MISCELLANEOUS PERSONAL PROPERTY:

All chickens and other barnyard fowl low located on the Santa Fe or Grubb Flat Ranches owned by the First Parties.

100 ton of hay, more or less, it being the intention

to include all hay now owned by the First Parties and located on the Santa Fe and Grubb Flat ranches owned by the First Parties in Eureka County, Nevada.

One ton of chicken feed wheat, and all other seed, grain, wheat and oats on hand and situate on the said Santa Fe and Grubb Flat ranches.

TO HAVE AND TO HOLD the same unto the said Second Party, its successors and assigns forever.

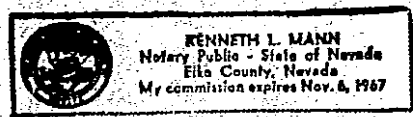
