State of Nevada, described as follows, to-wit:

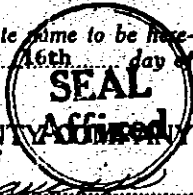

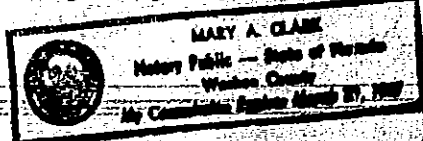
