**WITNESSETH:**

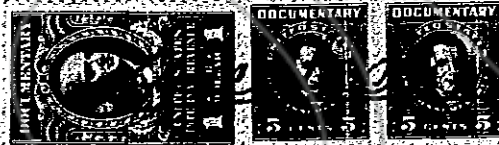

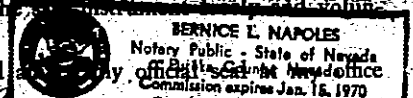
