

CANCELLATION OF ERRONEOUS RECONVEYANCE

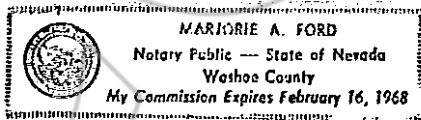

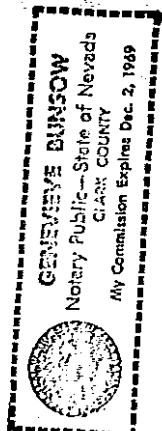
