The Northeast Quarter ($NE\frac{1}{4}$); the East Half ($E\frac{1}{2}$) of the Southeast Quarter ($SE\frac{1}{4}$); AND the Northwest Quarter ($NW\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section 19, Township 29 North, Range 52 East, M.D.M.; ALL of Section 35, Township 29 North, Range 51 East, M.D.M.; AND the Northeast Quarter ($NE\frac{1}{4}$) of the Northeast Quarter ($NE\frac{1}{4}$) of Section 1, Township 28 North, Range 51 East, M.D.M.

The remaining property described in said Deed of Trust shall continue to be held by said Trustee under the terms thereof. As provided in said Deed of Trust, this Partial Reconveyance is made without affecting the personal liability of any person for payment of the indebtedness secured by said Deed of Trust.

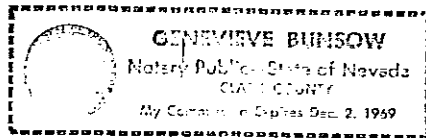
