

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the PROJECTION No. 6 Lode Mining Claim was located by EAST UTAH MINING COMPANY, whose post office address appears below, on the 11th day of APRIL, 1966

The general course of said lode or vein is NORTHERLY & SOUTHERLY
The claim is situated in the LYNN CREEK Mining District,
County, State of Nevada, in the S.W. 1/4 of Section 19, Township 36 North
Range 50 East, Mt Diablo, Meridian.

The locator's claim is 1400 feet in a NORTHERLY direction and 300 feet in a NORTHERLY direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:
AN OPEN CUT 50' in length X 5 feet in depth, made by a Bulldozer.

The total cost of such work consisted of at least \$ 150.00

The corners and side centers of the claim are located and marked as follows:

From the Southwest corner, a monument marked SW Cor., thence in a Northerly direction 750 feet to the West center corner, a monument marked WCC Cor., thence 750 feet in a Northerly direction to the Northwest Corner XXXX, a monument marked NWC SC, thence 600 feet in a Easterly direction to the Northeast corner, a monument marked NEC center Cor., thence 750 feet in a Southerly direction to the East side XXXX corner, a monument marked ESC Corner Cor., thence 750 feet in a Southerly direction to the Southeast XXXX corner, a monument marked SEC SC, thence 600 feet Westerly to the point of beginning.
