KNOW ALL MEN BY THESE PRESENTS, that M. H. WHITE, being first duly sworn, deposes and says;

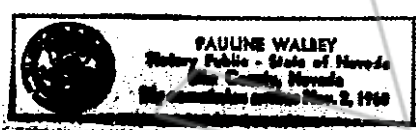
