

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the PANDORA No. 2 Lode Mining Claim was located by SUN TIDE CORPORATION, whose post office address appears below, on the 8th day of May, 19 66.

The general course of said lode or vein is NORTHERLY & SOUTHERLY.
The claim is situated in the BOOTSTRAP Mining District, EUREKA County, State of Nevada, in the NE $\frac{1}{4}$ of Section 26, Township 36 North Range 49 East, Mt Diablo Meridian.

The locator's claim 1400 feet in a NORTHERLY direction and 100 feet in a SOUTHERLY direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

Open cut trench over 75 feet in length, by 10 feet in width by over 10 feet in height and depth.

The total cost of such work consisted of at least \$ 150.00.

The corners and side centers of the claim are located and marked as follows:

From the Southwest corner, a monument marked S.W. Cor., thence in a Northerly direction 750 feet to the West side center corner, a monument marked WSC Cor., thence 750 feet in a Northerly direction to the North west ~~XX~~ Corner NW corner, a monument marked Northwest ~~XX~~ SW, thence 600 feet in a Easterly direction to the Northeast corner, a monument marked N.E. Cor., thence 750 feet in a Southerly direction to the East Side C corner, a monument marked ESC Cor., thence 750 feet in a Southerly direction to the Southeast ~~XX~~ SEC corner, a monument marked S.E. Corner ~~XX~~ SEC, thence 300 feet Westerly to the point of center, thence 100 feet Northerly to point of beginning.

Each of the above-described monuments is 4 X 4 Pine Posts.

All location and discovery work necessary to complete this location had been performed by July 22, 19 66.
