Issue having been joined on the Complaint filed herein and by Defendant's Answer to Plaintiff's Complaint, said Defendant answering by and through his Attorney, E. R. MILLER, JR., ESQ., and said case and cause coming on regularly for trial on this, the 15th day of July, 1966, at the hour of 10:00 o'clock, A. M., pursuant to Order of the Court duly entered herein on July 6, 1966, and Defendant above named having been duly and regularly served with a copy of the Order setting the above entitled case and cause for trial as by the Court ordered; and there being personally present in Court, HAROLD G. MILLER, on behalf of said Plaintiff above named, by and with his Attorney, C. E. HORTON, ESQ., of the firm of GRAY, HORTON AND HILL, ESQS., and said Defendant not being personally present in Court, but being represented by his Attorney, E. R. MILLER, JR., ESQ., and the Court having ordered that the trial proceed, and evidence both oral and documentary having been taken in open Court in support of Plaintiff's Complaint on file herein, and documentary evidence having been introduced on behalf of said Defendant; and the cause having been submitted, and the Court having duly considered all questions of law and fact arising herein and having been fully advised in the premises; and the Court having rendered its Findings of Fact and Conclusions of Law and ordered that

1 judgment and decree be entered in accordance therewith;

2 NOW, THEREFORE, IT IS HEREBY ORDERED that Plaintiff  
3 have judgment in the sum of Seven Hundred Eighty-seven Dollars and Ninety-  
4 eight Cents (\$787.98) against the above named Defendant.

5 IT IS HEREBY FURTHER ORDERED that Plaintiff have judgment  
6 in the sum of Two Hundred Fifty Dollars (\$250.00) against the above named  
7 Defendant, as and for attorneys' fees herein for services rendered by the firm  
8 of GRAY, HORTON AND HILL.

9 IT IS HEREBY FURTHER ORDERED that Plaintiff have and  
10 recover its costs in the sum of Forty-six Dollars and Thirty-five Cents  
11 (\$46.35) against said Defendant.

12 IT IS HEREBY FURTHER ORDERED that the sums hereinabove  
13 awarded to Plaintiff bear interest at the statutory rate of Seven Percent (7%)  
14 per annum from the date hereof until paid.

15 IT IS HEREBY FURTHER ORDERED that Writ of Execution  
16 issue herein.
