Section 17: NE¼ of SW¼ AND SW¼ of SW¼

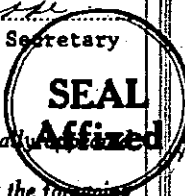
As to all other property described in said Deed of Trust the said Deed of Trust remains in full force and effect.
