

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Miner No. 8 Lode Mining Claim was located by Mr. Tom Costas, whose post office address appears below, on the 18th day of May, 1966.

The general course of said lode or vein is NORTHERLY & SOUTHERLY.

The claim is situated in the Pactstrap Mining District, Eureka, County, State of Nevada, SECTION 26, Township 36 North Range 49 East, MDM, This claim runs northerly & southerly.

The locator's claim 1400 feet in a NORTHERLY direction and 100 feet in a SOUTHERLY direction from the point of discovery, with a width of 500 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

The total cost of such work consisted of at least \$ 150.00.

The corners and side centers of the claim are located and marked as follows:

From the Southwest corner, a monument marked SW Cor, thence in a Northerly direction .750 feet to the West center corner, a monument marked W.C. corner, Cor, thence .750 feet in a Northerly direction to the Northwest center, a monument marked N.W.C. Cor, thence .600 feet in a East center direction to the Northeast corner, a monument marked N.E.C. Cor, thence Southerly .750 feet in a Southerly direction to the East side center corner, a monument marked E.S.C. Cor, thence .750 feet in a Southerly direction to the S.E. corner, a monument marked S.E.C. Cor, thence .300 feet Westward to center point, thence, 100 feet North to point of beginning, beginning, from this center point aforesaid 300 feet Westward to the SW corner.

Each of the above-described monuments is an 4x4 Pine Post.
