

PROOF OF ANNUAL LABOR AND STATEMENT OF THE POSITION OF THE CHICAGO NO.2, CHICAGO NO.3, CHICAGO NO.4, CHICAGO NO.7, CHICAGO NO.8, AND CHICAGO NO.9 LOCATED LOSE MINING CLAIMS, SITUATED IN SECTION 4, TOWNSHIP 35 NORTH, RANGE 50 EAST, M.D.B.M. EUREKA COUNTY OF NEVADA.

The Southwest Corner of the Chicago No.4 mining claim is situated 1800 feet East of the S.W. corner of Section 4, Township 35 N., Range 50 East, M.D.B.M., Eureka County of Nevada. The Southwest corner of the Chicago No.3 mining claim is situated 2400 feet East of the said Southwest corner of Section 4 and is a common corner with the Southeast corner of the Chicago No.4 claim. The Southwest corner of the Chicago No.2 claim is situated 3000 feet East of the Southwest corner of Section 4 and is a common corner with the Southeast corner of the Chicago No.3 claim. The Southeast corner of the Chicago No.2 claim is situated 3600 feet East of the Southwest corner of the above defined Section 4.

The Northwest corner of the Chicago No.4 mining claim is situated 1800 feet East and 1500 feet North of the Southwest corner of said Section 4. The Northwest corner of the Chicago No.3 mining claim is situated 2400 feet East and 1500 feet North of the Southwest corner of Section 4 and is a common corner with the Northeast corner of the Chicago No.4 mining claim. The Northwest corner of the Chicago No.2 mining claim is situated 3000 feet East and 1500 feet North of the Southwest corner of said Section 4 and is a common corner with the Northeast corner of the Chicago No.3 mining claim. The Northeast corner of the Chicago No.2 mining claim is situated 3600 feet East and 1500 feet North of the Southwest corner of said Section 4.

The discovery monument of the Chicago No.4 claim is 2100 feet East and 100 feet north of the S.W. corner of Section 4. The discovery monument of the Chicago No.3 claim is 2700 feet East and 100 feet North of the S.W. corner of Section 4. The discovery monument of the Chicago No. 2 claim is 3300 feet East and 100 feet North of the S.W. corner of Section 4.

The Southwest corner of the Chicago No.7 mining claim is 1800 feet East and 1500 feet North of the Southwest corner of said Section 4. The Southwest corner of the Chicago No.8 claim is 2400 feet East and 1500 feet North of the Southwest corner of said Section 4 and is a common corner with the Southeast corner of the Chicago No.7 mining claim. The Southwest corner of the Chicago No.9 claim is 3000 feet East and 1500 feet North of the Southwest corner of said Section 4 and is a common corner with the Southeast corner of the Chicago No.8 mining claim. The Southeast corner of the Chicago No.9 mining claim is situated 3600 feet East and 1500 feet north of the Southwest corner of said Section 4.

The Northwest corner of the Chicago No.7 claim is 1800 feet East and 3000 feet North from the Southwest corner of said Section 4. The Northwest corner of the Chicago No.8 mining claim is 2400 feet East and 3000 feet North from the Southwest corner of Section 4 and is a common corner with the Northeast corner of the Chicago No.7. The Northwest corner of the Chicago No.9 claim is 3000 feet East and 3000 feet North from the Southwest corner of Section 4 and is a common corner with the Northeast corner of the Chicago No.8 claim. The Northeast corner of the Chicago No.9 claim is 3600 feet East and 3000 feet North from the Southwest corner of Section 4.

The discovery monument of the Chicago No.7 claim is 2100 feet East and 1600 feet North of the Southwest corner of Section 4. The discovery monument on the Chicago No.8 claim is 2700 feet East and 1600 feet North of the Southwest corner of Section 4. The discovery monument on the Chicago No.9 claim is 3300 feet East and 1600 feet North of the Southwest corner of said Section 4.

The annual assessment work on the above defined six located lode mining claims, the Chicago No.2, Chicago No.3, Chicago No.4, Chicago No.7, Chicago No.8 and Chicago No.9 has been performed by A.B.Thomas of 39 Exchange Place, Salt Lake City, Utah as Lessee from the Locator owner of the claims. The work involved was performed at various dates between Sept, 2nd, 1965 and August 1st, 1966 and the value of the "on the ground" expenditure was in excess of \$600.00 . It consists of long bull-doser trenches driven as an aid to uncover structures for examination plus geologic study and the gathering of data for a geologic report by Thomas P. Costas of Salt Lake City, a qualified person under the State of Nevada regulations for this purpose. Supplemental work of similar nature was undertaken by the Lessee , A.B.Thomas. Receipts, in the nature of cancelled checks given as payment for work performed, and given for work performed "on the ground" in excess of six hundred dollars, are held for examination as necessary by Arthur Blake Thomas, 39 Exchange Place, Salt Lake City, Utah.
