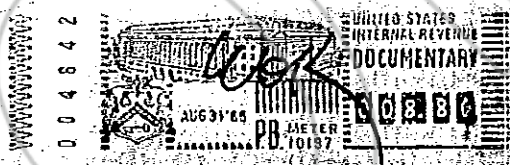
The Southwest quarter of Section 35, Township 29 North, Range 48 East, M.D.B. & M., as per government survey.

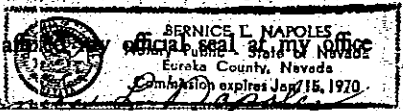
