WITNESSETH:

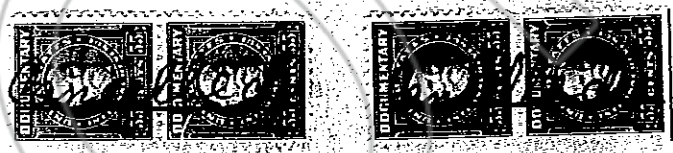
