This grant shall be effective so long as the easement shall be actually used for the aforesaid purposes, and all rights hereunder shall revert to the grantor/whom and in the event the use thereof shall be discontinued or chandoned by the grantee of which due notice shall be given to the grantor by the grantee. Upon termination or shandonment of this exserted, the grantee may at its option and within a reasonable time, remove any improvements constructed by it on the load hereunder.
