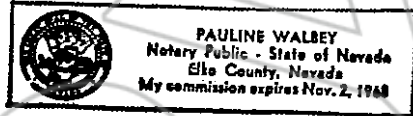
Said labor was performed by employees and a contractor, Eklund Drilling Company and its employees between the twenty-third (23rd) day of
