12 CONFESSION OF JUDGMENT WITHOUT ACTION

15 above-entitled action and hereby confesses judgment in favor of Plaintiff in  
16 the amount of Four Hundred Fourteen and 23/100 (\$414.23) Dollars, lawful  
17 money of the United States, together with the sum of Ten and no/100 (\$10.00)  
18 Dollars, court costs and Fifty and no/100 (\$50.00) Dollars, attorney fees,  
19 and hereby consents that the Clerk of the above-entitled Court duly enter  
20 judgment for the total amount of Four Hundred Sixty-four and 23/100  
21 (\$464.23) Dollars, against me.

23 I further state that the said amount is justly due and owing by me to  
24 said claimant as payment in full for merchandise sold to me.

26 The total sum above stated, plus interest at the legal rate of 7% per  
27 year on the unpaid balance, to be paid as follows: Ten Dollars upon signing  
28 this Confession and the balance of Four Hundred Fifty-four and 23/100  
29 Dollars, plus interest at the legal rate of 7% per year on the unpaid balance  
30 in regular installments of Twenty-five and no/100 (\$25.00) Dollars, the first

1 of each and every month until paid in full beginning September 1, 1966.

2 It is further understood and agreed that default in the payment of any  
3 installment, as above stated, when due, and without notice or demand, ren-  
4 ders the then unpaid balance, plus interest due, at once due and payable in  
5 full, and that execution may issue for payment in full of the balance due.

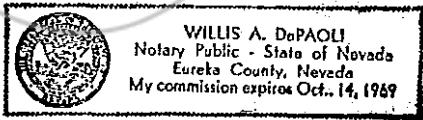
